We only need a microphone and I think that has been solved also as of last night. Thank you all!
4. There is a suggestion to restrict our Personal Users to a total of 200. This was open for suggestion or recommendation by anyone wishing to speak. Several mentioned we should keep it open so long as the radio waves can support it and it brings in new CREST team members. We will continue to accept new Personal users.
5. A new repeater was just placed on the air in Rancho Cucamonga. It is on 600MHz with a PL of 141.3. It is an open repeater at this time.
